MIAMI SKI CLUB TRIP POLICY

ELIGIBILITY FOR TRIPS

1. Only members of the Miami Ski Club and its Florida Ski Council affiliates are eligible for trips.
2. Current members take precedence over applications for membership at the time the trip application is received.
3. Applicants for membership will be permitted to participate if a completed membership application form with the appropriate fees attached accompanies or precedes the trip application form.
4. Any person under the age of 21 years of age must be escorted by a parent or legal guardian, or other person over the age of 21, who shall assume full responsibility for his/her safety and conduct. (THIS RULE IS ADOPTED BY THE CLUB WITH THE FULL KNOWLEDGE THAT THE LEGAL AGE OF ADULTHOOD IN THE STATE OF FLORIDA IS 18 YEARS OF AGE.)
5. It will be each trip participant's responsibility to legibly complete and sign the trip application form.

DEPOSITS AND FEES

1. Full payment to the Miami Ski Club of the stated cost of the trip is required prior to participation of a traveler on the trip.
2. Deposit fees for each trip will be unique to the trip. You can transfer the deposit with prior written approval of the Vice President of Trips.
3. A late fee of \$50.00 per trip application will be assessed if payment in full is not received or postmarked by the Final Payment date.
4. The Miami Ski Club reserves the right to increase prices in the event of any security or fuel related surcharges or airfare increases imposed by the airline that may be in place at the time of ticketing or travel, foreign or domestic tax increases, or adverse currency exchange fluctuations. A surcharge may be imposed if these costs increase.

OCCUPANCY POLICY

The Miami Ski Club shall make every effort to provide the requested lodging, i.e., single, double, 2/bedroom., 3/bedroom., etc. The trip participant will be assessed the amount for the actual lodging used. The number of people in each room is limited to the occupancy listed by the Miami Ski Club at the time of trip purchase. Any exceptions need to be approved in writing by the Vice President of Trips.

CANCELLATIONS

1. Deadlines for full payment and a cancellation date for each trip will be established by the Vice President of Trips, and will be published by the Trip Leader of the trip at least one month prior to the payment deadline(s). Inclusion of such information in the trip flyer shall be deemed sufficient notice of such deadline(s) to all trip participants.
2. If full payment of the trip has not been received by the Trip Leader by the established deadline, it may be at the discretion of the Trip Leader to replace that person with another person on the waiting list.
3. All travelers wanting to cancel their participation on a Miami Ski Club trip must complete a trip cancellation form provided by the Trip Leader. Completed trip cancellation forms are submitted to the Trip Leader and the traveler's space on the trip is returned to the Miami Ski Club.
4. If notification of cancellation is received by the Trip Leader prior to the cancellation date, a penalty of \$75.00 per application will be assessed. If notification of cancellation is received by the Trip Leader after the cancellation date, then each person will incur a \$150.00 penalty plus any expenses incurred by the Club.
5. If a refund is to be made, the refund can be held until after the trip has been completed and all outstanding expenses have been received by the Vice President of Trips.

CANCELLATION AND CHANGE OF LOCATION OF TRIPS BY THE CLUB

1. CANCELLATION AND CHANGES OF LOCATION of a trip will be at the discretion of the Miami Ski Club's Executive Committee.
2. Full refund to trip participants will be made in the event of cancellation of a trip by the Miami Ski Club. Exceptions to this must be reviewed and approved by the Executive Committee.

INJURY POLICY

If a trip participant is injured on a Miami Ski Club sponsored trip and is required to return home early, the Trip Leader will assist the injured person in communication with family and friends and to make alternative travel arrangements. The Miami Ski Club will not be financially responsible for any additional costs to the injured person including taxi fares to the hospital, clinic, etc. The cancellation policy still applies if the trip participant must cancel future trips because of the injury. The purchase of third party travel insurance is recommended for all trip participants.

RESPONSIBILITY

The Miami Ski Club Inc., and cooperating agents act only as agents and assume no responsibility or liability in connection with the service of any carriage, aircraft, motor, or other conveyance which may be used wholly or in part in the performance of its duty to the passengers; neither will they be responsible for any act, error, or omission for any injury, loss, damage, accident, delay, or irregularity, which may be occasioned by reason of any defect in any vehicle, or through neglect or default of any company engaged in conveying the passenger, or any hotel, lodge or condominium service or any other person engaged in carrying out the purpose for which this trip is sold. In the event it becomes necessary for any reason whatsoever to alter the itinerary or arrangements, such alterations may be made without penalty to the Miami Ski Club. The Miami Ski Club reserves the right to cancel or alter any trip at any time. In case of cancellation, the Miami Ski Club will not be liable for more than the passenger has paid to the Miami Ski Club. In case of lack of snow during the ski season, refund policies established by each lodging facility and ski area will be upheld by the Miami Ski Club. The refund policy that governs each trip will be dependent upon the area chosen. Your cooperation in these matters is appreciated.
